...A proposed ordinance is now being considered by the County of San Diego for the control of overdrafted groundwater basins. The ordinance would be limited to severely overdrafted basins without imported water or water districts. It would also be a temporary solution and would not attempt to adjudicate the water rights. The ordinance would, at the discretion of the Board of Supervisors, limit groundwater production, increase irrigation efficiency, and assess fees or penalties. The ruling would only remain in effect until the basin had returned to normal levels.

The proposed ordinance would require that a committee of 5 individuals study the overdrafted basin and make mitigation recommendations to the Board. The committee would be composed of representatives from: (1) San Diego Association of Geologists (2) Farm Bureau (3) Local Citizens Group (4) soil scientist or irrigation specialist and (5) chaired by the County Groundwater Geologist. The committee would be responsible for determining the condition of the groundwater basin and making recommendations for direct mitigation.

The proposed ordinance is now being reviewed and refined. Hopefully it will be taken to the Board this Fall. If you have any comments or would like to review the draft ordinance, please contact John Peterson at 565-3042.
