- 1) Our speaker this month is Dr. Mark R. Legg. Mark currently works for ACTA Incorporated in Torrance, California. He received his PhD in geological sciences from the University of California, Santa Barbara in 1985. His talk will cover the inner California continental borderland which is a complex part of the Pacific-North American active plate boundary shear zone. Detailed marine geophysical surveys show that this offshore region is underlain by two major, Late Quaternary, right-slip fault systems, the Agua Blanca and San Clemente fault systems.



Cost includes parking, transportation, breakfasts, two lunches, Saturday night dinner, munchies, beverages, Saturday night accommodations at Hotel Mision Santa Isabel in Ensenada, and a copy of the joint SCEPP/SDAG/USGS publication on the Rose Canyon fault zone, which will include the road log for this field trip.

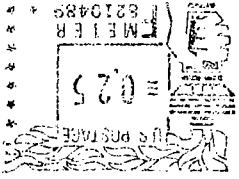
