Woodward-Clyde Consultants was retained by a coastal design engineering firm to conduct studies on the Island of Kosrae in Micronesia. The project goal was to identify sources of sand and armor stone for construction of a shoreline protection structure. Approximately 3,000 feet of beach was eroded during storm events after areas of the reef flat had been excavated for road fill during construction of an airport and harbor facility. With funds from the settlement of a lawsuit (yes, it even happens on tropical islands), design and geotechnical work was undertaken that will ultimately lead to restoration of the beach and save the local homes, a church, and a road from being carried away by the sea.

The talk will discuss the project, the geology encountered during the field studies, the culture and wonderful people of Kosrae. Daryl Streiff is a consulting engineering geologist, and Mike Hatch is an associate with Woodward-Clyde Consultants.

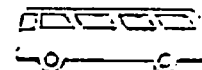
