7. **Andrei Farcas Benefit Fund**- On Wednesday, June 9th, our friend, colleague, and former SDAG chairman, Andrei Farcas, suffered a severe heart attack and stroke while mowing his lawn. Fortunately, Andrei's son, Serban, saw what was happening and immediately called paramedics. Had it not been for the fast action of Serban, Andrei almost certainly would have died at the scene, since he had no vital signs when Serban reached him. Andrei is now in the Cardiac Care unit at UCSD Medical Center in Hillcrest. Although his condition has stabilized, he still requires breathing assistance at least part of the time and is partially paralyzed on his left side. As you might expect, the treatment of Andrei's condition will generate substantial medical bills. He also faces a long period of recuperation and rehabilitation. Since he is self-employed, he does not have health insurance. A bank account to which contributions may be made for Andrei's benefit is being established. This is a very difficult time for Andrei, his wife Smaranda, and his son. Any support we can give, emotional or financial, will help in their time of need. Please be generous. 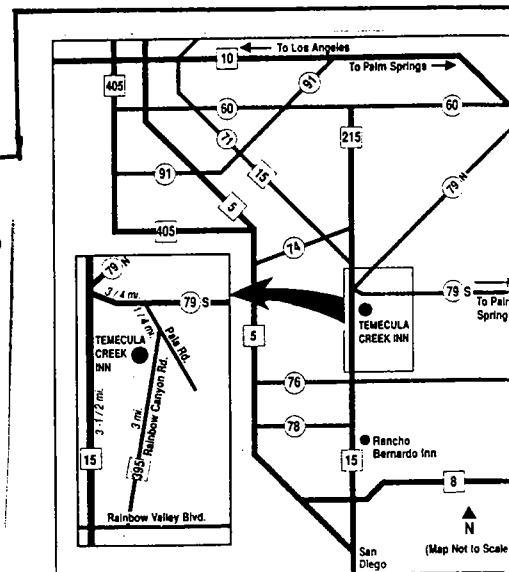

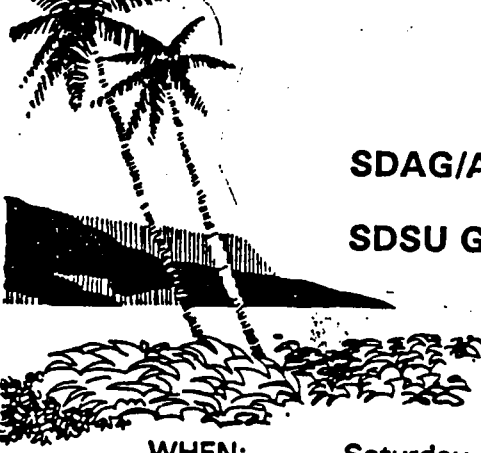

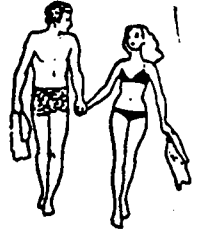

A volleyball net will be set up- Bring your beach chairs, sunscreen, and your favorite toys!!

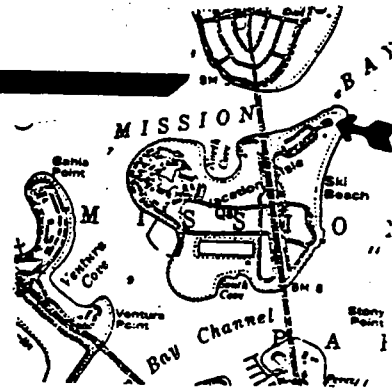
